Chattanooga Career Center Changes Procedures

TN Department of Labor & Workforce Development Procedures to Assist Veterans at the Chattanooga Career Center

Federal guidelines are changing the way the centers do business.

Veterans are our top priority and receive priority of service.

Upon entering the TN Career Center at Chattanooga a veteran would:

- Sign in at the Front Desk
- Complete a Military Services Form
- Be Assessed by a Labor Staff Member
- All veterans are required to be assessed by a career specialist in person or by telephone. If it is determined they have a significant barrier to employment (SBE), see attachment, our staff member would do a referral for VOS services listed: Intensive Services; resume services, interviewing skills, Jobs4tn.gov services, and etc., Case Management Services, and Employment Opportunity Services.
- When referring a veteran to the career center, please do not give out the VOS names and telephone numbers. The clients must go through the above assessment procedure prior to talking with a VOS. Below are two career specialist veterans available to assist anyone you wish to refer, feel free to give out their names and telephone numbers. These are direct lines to their desk or voice mail.

Veterans Treatment Court

An effort is underway to help Hamilton County veterans in criminal trouble. A Veterans Court gives such veterans a second chance.

A Veterans Treatment Court diverts eligible veterans from the traditional criminal justice system and allows them to receive specialized support and rehabilitation. Veterans Administration provides counseling and treatment. Veterans Courts are being used in four of the major urban areas of Tennessee (and in about 200 other locations in the United States). A unique component of the Veterans Court is the use of mentors. Mentors are primarily other concerned veterans who volunteer to provide encouragement and support to the counselee and his family as the veteran progresses through his rehabilitation and treatment. Much more work is needed to establish the Court, so further updates will be given as headway is made. Mentor volunteers will be needed. Please back the formation of a Veterans Court in Hamilton County.

UTC Offers Day of Assistance to Veterans

The Educational Opportunity Center and the UTC Departments of Veteran Student Services, Financial Aid, and Records are teaming up to offer a day of assistance with all things financial as well as information about Veteran student services.

MYTHS

If I am using GI benefits, I am not eligible for Federal Financial Aid.

I have to have my 2014 tax return done before I complete the 2015-2016 FASFA.

Students with full Veteran's educational benefits are not eligible for Federal Financial Aid or scholarships.

THE TRUTH

Veterans pass up free \$\$ every year because they think they are not eligible and do not apply. Some money is awarded on a first come, first served basis – let us help you file your FASFA EARLY for 2015-2016.

Veterans with a service connected disability rating with VA may be eligible for Vocational Rehabilitation entitlements regardless of age. To confirm eligibility go to: http://campuscms52.ucmerced.edu/veterans/chapter-31

Our goals for this open house are to assist our Veteran and military families with:

- Completing the 2015-2016 FAFSA and the scholarship applications.
- Learn about the HOPE for non-traditional students, the Yellow Ribbon program, and other scholarships you may be eligible for.
- Ask questions about Veteran Student Services and Veteran's educational benefits as well as financial planning and budgeting.

WHAT TO BRING:

If possible, bring the following for yourself (and your spouse if you are married.) Dependent children 18-25 may need to bring parents tax return if they do not qualify as a veteran. If you do not have these documents available, please come to the Open House anyway. We can file the FAFSA using estimates.

- 2014 year end wage statement (check stub) for all jobs in 2014 or W-2s
- Total amount of child support paid or received
- First 2 pages of 2014 tax return
- Amount of any Veteran Disability pay received in 2014
- DD 214 Proof of military service
- VA Disability Rating Notification
